#### **RESOLUTION No. 20-0217-01**

# RESOLUTION REQUESTING THAT THE DELAWARE GENERAL ASSEMBLY AMEND THE CHARTER OF THE CITY OF DELAWARE CITY REGARDING RESIGNATIONS BY COUNCIL MEMBERS

WHEREAS, the City Charter of the City of Delaware City (the "City") requires the Mayor and Councilpersons (collectively, the "Council"), upon submitting resignation, to remain in elected office unless or until his or her successor is appointed; and

WHEREAS, the Council has determined that finality in resignations by its members is important to administering City business, reaching quorums, and identifying new members to serve.

WHEREAS, the Council has determined that Article III, Section 3-09 of the City Charter (Vacancies and Forfeiture of Office) should be amended to expressly provide that all resignations are effective immediately; and

WHEREAS, the Council believes that it is in the best interest of the City and its citizens if Article III, Section 3-09 of the City Charter (Vacancies and Forfeiture of Office) be amended, which shall read as follows:

A. Vacancies. The office of Mayor or Councilperson shall become vacant upon death, removal from the City, resignation, removal from office in any manner authorized by law, or forfeiture of office. Notwithstanding any other provision in this Charter, a

## Sec. 3-09. Vacancies and Forfeiture of Office.
